## **RESOLUTION NO. 2017-181**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH THE FORMAL REQUEST FOR PROPOSAL PROCEDURES PURSUANT TO ELK GROVE MUNICIPAL CODE SECTION 3.42.140(B)(3) AND AUTHORIZING THE CITY MANAGER TO EXECUTE A THREE YEAR CONTRACT WITH VAN SCOYOC ASSOCIATES INC. FOR FEDERAL GOVERNMENT RELATIONS SERVICES WITH A NOT-TO-EXCEED AMOUNT OF \$183,600

WHEREAS, the City of Elk Grove has contracted with Van Scoyoc Associates, Inc. since April 2006 to provide Federal Government Relations Services to the City; and

**WHEREAS**, this firm is familiar with the goals and priorities of the City, as well as the City's Congressional delegation and their staffs; and

**WHEREAS**, this firm has been working on the City's behalf in Washington, D.C. on many fronts over the last several years as outlined in the staff report; and

WHEREAS, for the reasons presented, a formal solicitation for the proposed services will not be in the best interest of the City, and the expenditure of time and money is not likely to result in an outcome more advantageous to the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove, having determined that a request for proposals ("RFP") process for securing Federal Government Relations Services is not in the best interests of the City, hereby dispenses with the formal RFP procedures pursuant to Elk Grove Municipal Code Section 3.42.140(B)(3); and

BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to enter into a contract with Van Scoyoc Associates, Inc. in substantially the form presented, for Federal Government Relations Services for three years with a not-to-exceed amount of \$183,600.
