A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE USE OF CFD 2005-1 LAGUNA RIDGE FUNDS TO CONSTRUCT
CERTAIN ELK GROVE ROADWAY FEE ELIGIBLE FACILITIES FOR NEW GROWTH
AREA (NGA) PROJECTS BIG HORN BOULEVARD EXTENSION (WTR026) AND
BILBY ROAD EXTENSION (WTR029) AND DIRECTING A RECONCILIATION OF
PROJECTS COSTS AFTER A NOTICE OF COMPLETION (NOC) HAS BEEN FILED
FOR THE PROJECTS AND FURTHER DIRECTING PREPARATION OF A
REPAYMENT PLAN AFTER FILING OF THE NOC

WHEREAS, the Big Horn Boulevard Extension Project (WTR026) and the Bilby Road Extension Project (WTR029) ("Projects") are both New Growth Area (NGA) Projects that are crucial to the timely development of the southwestern portion of the Laguna Ridge Specific Plan (LRSP) and employment oriented development in the Southeast Policy Area (SEPA); and

WHEREAS, on October 22, 2014, the City Council adopted an 11-point implementation plan for critical backbone infrastructure in the Southeast Policy Area (SEPA) to remain competitive in attracting employment-generating uses which included the Projects; and

WHEREAS, on May 13, 2015, the Phasing and Financing Plan provided advanced funding of the Projects using funds from the Elk Grove Roadway Fee (EGRF) (Fund 328) and the Laguna Ridge CFD 2005-1 (CFD 2005-1) (Fund 344); and

WHEREAS, the Projects are included in the approved Fiscal Year 2017-22 Capital Improvement Program and are budgeted with funds in the approved Fiscal Year 2017-18 Budget; and

WHEREAS, the Projects were designed and will be constructed by the City; and

WHEREAS, EGRF funds are not sufficient to fund Roadway eligible costs; and

WHEREAS, CFD 2005-1 has sufficient resources to loan dollars for Roadway Fee eligible facilities that will subsequently be repaid to CFD 2005-1 from the EGRF; and

WHEREAS, the final cost allocation between the two funding sources for eligible Projects costs will not be finalized until after the Projects' completion.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk-Grove hereby:

1) Directs the use of CFD 2005-1 Laguna Ridge funds to construct certain Elk Grove Roadway Fee eligible facilities for New Growth Area (NGA) Projects Big Horn Boulevard Extension (WTR026) and Bilby Road Extension (WTR029);

- 2) Directs a reconciliation of costs for the construction of New Growth Area (NGA) Projects Big Horn Boulevard Extension (WTR026) and Bilby Road Extension (WTR029) after the filing of a Notice of Completion (NOC) for the Projects; and
- 3) Further directs the preparation of a repayment plan after the filing of an NOC for the Projects Big Horn Boulevard Extension (WTR026) and Bilby Road Extension (WTR029).
