STATES DEPARTMENT OF AGRICULTURE, ANIMAL AND PLANT HEALTH
INSPECTION SERVICE - WILDLIFE SERVICES AND AUTHORIZING THE CITY
MANAGER TO EXECUTE THE WORK AND FINANCIAL PLANS FOR THE
REMAINING TERM OF THE AGREEMENT**


WHEREAS, the City of Elk Grove (City) and United States Department of Agriculture, Animal and Plant Health Inspection Service - Wildlife Services (APHIS-WS) entered into a five-year Cooperative Service Agreement (Agreement) in 2016 for wildlife management services; and

WHEREAS, the APHIS-WS has expertise in conducting wildlife damage management activities to assist the City in minimizing damage to property, waterways and flood structures from damage caused by beavers; and

WHEREAS, the proposed agreement with the APHIS-WS is not susceptible to competitive bidding, and entering into this agreement is in the best interest of the City.


NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby accepts and ratifies the Cooperative Service Agreement with an effective date of September 1, 2016 and an expiration date of June 30, 2021 and Work and Financial Plans for Fiscal Years 2016/2017 and 2017/2018 and authorizes the City Manager to execute annual Work and Financial Plans for the remaining term of the Agreement.


