

RESOLUTION NO. 2017-274

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AMENDING THE FISCAL YEAR 2017-18 BUDGET AND 2017-2022 CAPITAL
IMPROVEMENT PROGRAM FOR 2018 PAVEMENT SEALING PROJECT (WPR018)
BY \$298,000 AND CITYWIDE CURB RAMPS 2018 (WAC013) BY \$386,000**

WHEREAS, Senate Bill 1 (SB 1), the Road Repair and Accountability Act of 2017 (Chapter 5, Statutes of 2017) was passed by the Legislature and signed into law by the Governor in April 2017 creating the Local Partnership Program; and

WHEREAS, these funds can be used for preliminary engineering, construction engineering, and/or construction phases, conditioned upon a 1-to-1 local funds match by the City; and

WHEREAS, on December 6, 2017, Sacramento Transportation Authority identified the City's Local Partnership Program allocation of \$621,000, for the next two fiscal years, for the formulaic program component of SB1; and

WHEREAS, The California Transportation Commission will formally adopt the formulaic calculation process at their December 6 & 7 meeting and the program at their January 31 meeting; and

WHEREAS, Staff has identified two projects that qualify for these funds – the 2018 Pavement Sealing Project (WPR018) and the Citywide Curb Ramps 2018 Project (WAC013); and

WHEREAS, Staff recommends that \$298,000 be allocated to the 2018 Pavement Sealing (WPR018) and \$386,000 be allocated to the Citywide Curb Ramps 2018 (WAC013).

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby amends the Fiscal Year 2017-18 Budget and 2017-2022 Capital Improvement Program to increase funding for the 2018 Pavement Sealing Project (WPR018) in the amount of \$298,000 from SB1 Local Partnership Funds (Fund 228), and increase funding for the Citywide Curb Ramps 2018 Project (WAC013) in the amount of \$323,000 from SB1 Local Partnership Funds (Fund 228) and \$63,000 from Gas Tax Funds (Fund 221), upon formal notification from Sacramento Transportation Authority that the funds are available.


