A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO ACCEPT GRANT FUNDING FROM THE BLOOMBERG MAYORS CHALLENGE CHAMPION CITY PROGRAM AND AMENDING THE FISCAL YEAR 2017-2018 BUDGET TO APPROPRIATE THE BLOOMBERG MAYORS CHALLENGE CHAMPION CITIES GRANT IN THE AMOUNT OF \$100,000

**WHEREAS**, in October 2017, the City applied to the Bloomberg Mayors Challenge, which is a program designed to help local community tackle a major issue and develop innovative solutions towards that issue; and

**WHEREAS**, in February 2018, it was announced that the City was selected as a Champion City; and

WHEREAS, as part of the Bloomberg Mayors Challenge Champion City phase, the City has been awarded \$100,000 towards further developing the project idea in preparation for final application in August 2018.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby

- 1) Authorizes the City Manager to accept grant funding in the amount of \$100,000 from the Bloomberg Mayors Challenge Champion City Program to continue development of the Renters Application Project in preparation for the final application in August of 2018; and
- 2) Amends the Fiscal Year 2017-18 Budget to appropriate the Champion Cities Grant as follows:

Strategic Initiatives and Long Range Planning Operating Expenses (107-3150)

\$100,000; and

3) Approves re-appropriation in the Fiscal Year 2018-19 Budget of any Grant funds not expended in the current fiscal year.
