## **RESOLUTION NO. 2018-119**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE ACCEPTING THE CITYWIDE CURB RAMPS 2017 PROJECT (WAC012) AS COMPLETE; AND AUTHORIZING THE CITY ENGINEER TO PREPARE AND THE CITY CLERK TO FILE THE NOTICE OF COMPLETION WITH THE SACRAMENTO COUNTY RECORDER

WHEREAS, on August 23, 2017, the City Council authorized the award of a construction contract to Sierra National Construction, Inc., for the Citywide Curb Ramps 2017 Project (WAC012); and

WHEREAS, the Project included construction for the removal of accessibility barriers to persons using wheelchairs or other personal assistance devices by reconstructing 42 curb ramps at 18 intersection locations to meet current Americans with Disabilities Act (ADA) accessibility requirements; and

WHEREAS, Sierra National Construction, Inc. has completed the work in accordance with the terms and conditions of the contract documents for the Project; and

WHEREAS, if no liens or claims have been filed within thirty-five (35) days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to Sierra National Construction, Inc.; and

WHEREAS, post construction work is typically completed within one hundred twenty (120) days of the City Clerk filing the Notice of Completion with the Sacramento County Recorder and then all invoices can be paid, any remaining project budget authority would be adjusted to zero.

**NOW**, **THEREFORE**, **BE IT RESOLVED** that the City Council of the City of Elk Grove hereby:

- 1) Accepts the Citywide Curb Ramps 2017 Project (WAC012) as complete;
- Authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder; and
- Authorizes staff to amend the Arinual Budget and Capital Improvement Program by reducing the remaining project budget authority to zero and returning any remaining funds back to their respective fund.
