

RESOLUTION NO. 2018-116

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE THE FIRST AMENDMENT TO
THE AGREEMENT BETWEEN THE CITY OF ELK GROVE AND THE CITY OF GALT
FOR PARTICIPATION AT THE SPECIAL WASTE COLLECTION CENTER TO
INCREASE THE ANNUAL AMOUNT TO \$35,000 AND THE TOTAL AGREEMENT
AMOUNT TO \$140,000**

WHEREAS, in November 2016, the City of Elk Grove entered into an Agreement with the City of Galt for use of the Special Waste Collection Center (SWCC) for a period of 3.5 years; and


WHEREAS, the number of City of Galt residents using the SWCC has increased and the budget for Fiscal Year 2017-18 is estimated to exceed the total annual Agreement limit of \$25,000; and

WHEREAS, The City of Galt and City of Elk Grove both project that additional growth in the number of Galt residents visiting the SWCC is likely, which will cause a continued increase in annual costs for the City of Galt; and

WHEREAS, to continue using the City of Elk Grove SWCC for Galt residents, the Agreement must be amended to increase the total spending authority of the City of Galt.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute the First Amendment to the Agreement between the City of Elk Grove and the City of Galt for participation at the Special Waste Collection Center to increase the annual limit to \$35,000 and the total Agreement amount to \$140,000.


