RESOLUTION NO. 2018-145

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE FINANCE DIRECTOR TO EXERCISE THE SALE OF, OR OTHERWISE DISPOSE OF, SURPLUS CITY PROPERTY IN THE FORM OF LAW ENFORCEMENT VEHICLES, EMERGENCY RESPONSE EQUIPMENT, CITY VEHICLES, EQUIPMENT, AND TRANSIT VEHICLES

WHEREAS, the City of Elk Grove purchased, and/or acquired through donation, vehicles and equipment to be utilized by the Elk Grove Police Department in the normal course of its duties; and

WHEREAS, the City acquired vehicles to be utilized by the City's Transit Division in the normal course of its duties; and

WHEREAS, the City purchased equipment to be utilized by the Elk Grove Public Works Department in the normal course of its duties; and

WHEREAS, staff has designated twelve law enforcement vehicles as surplus, as they have reached the end of their service life based on years in service, high mileage, and/or frequency/cost of repairs; four transit buses as surplus, as they have reached the end of their Federal Transit Administration (FTA) useful life; one City vehicle; and two pieces of equipment as surplus, as they have reached the end of their service life; and

WHEREAS, the law enforcement vehicles are equipped with emergency response equipment that shall be removed prior to any public sale; and

WHEREAS, Elk Grove Municipal Code Chapter 3.42 specifies the terms and conditions for the disposition of surplus City property; and

WHEREAS, the City of Elk Grove desires to surplus twelve law enforcement vehicles, the associated emergency response equipment, four transit buses, one City vehicle and two pieces of equipment, and sell them at fair market value or otherwise dispose of the assets.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the Finance Director to exercise the sale or disposal of surplus City property in the form of twelve law enforcement vehicles, four transit buses, one City vehicle and two pieces of equipment, including the disposal of any associated emergency response equipment, as described in Exhibit A to this resolution, incorporated herein by this reference, through sale to other law enforcement agencies, reuse by the City, or designated as unsalvageable, based on the needs of the City; and

AND BE IT FURTHER RESOLVED that proceeds from any sale or disposal of the surplus vehicles shall be deposited into the Facilities and Fleet Internal Services Fund and Transit Fund, respectively.
