A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH THE COMPETITIVE PROPOSAL PROCESS PURSUANT TO ELK GROVE MUNICPAL CODE SECTION 3.42.188(B)(3) AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH THE COUNTY OF SACRAMENTO FOR THE CITY'S PROPORTIONATE SHARE OF HAZARDOUS MATERIALS EMERGENCY RESPONSE SERVICES FOR FISCAL YEAR 2017-2018 IN AN AMOUNT NOT TO EXCEED \$103,165.88

WHEREAS, the County of Sacramento has requested the City of Elk Grove pay their proportionate share of costs related to hazardous materials response services within the incorporated limits of Elk Grove; and

WHEREAS, the County of Sacramento has prior agreements directly with the City of Sacramento Fire Department and the Sacramento Metropolitan Fire District for these services; and

WHEREAS, the prior agreement came to term on June 30, 2017; and

WHEREAS, it is necessary to enter into an agreement for services provided by the City of Sacramento Fire Department and the Sacramento Metropolitan Fire District from July 1,2017 through June 30, 2018; and

WHEREAS, CSD Fire is not equipped or trained to handle Level II and Level III hazardous incidents and staff has not found any other entity that can provide similar response services; and

WHEREAS, for the reasons presented, it is not in the best interest of the City to conduct formal competitive bidding for hazardous materials emergency response services.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby determines that formal competitive bidding is not in the best interest of the City and hereby dispenses the formal bid requirements pursuant to Elk Grove Municipal Code Section 3.42.188(B)(3); and

BE IT FURTHER RESOLVED that the City Manager is hereby authorized to execute an agreement with the County of Sacramento for hazardous materials response services in an amount not to exceed \$103,165.88.
