A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE APPROVING THE RELOCATION OF PUBLIC ART AT THE CIVIC CENTER AND REALLOCATING FUNDS DESIGNATED FOR THE REFLECTING POOL AT THE BASE OF THE ICONIC SCULPTURE

WHEREAS, the City Council adopted Resolution No. 2017-60 to approve the Civic Center Public Art; solicit new proposals for a kinetic piece and music sculpture; and allocate \$100,000 to the project for the addition of a reflecting pool at the base of the exterior iconic artwork; and

WHEREAS, as construction of the Civic Center facilities have progressed several issues have arisen, prompting staff to recommend the following three amendments to Resolution 2017-60; and

WHEREAS, the relocation of the iconic sculpture to another area within the Civic Center Commons is recommended by staff as the current placement has obstructed views due to the buildings and trees. Moving the iconic sculpture to a prominent location where it is visible from multiple locations with little obstruction will allow it to be the signature piece for the Civic Center; and

WHEREAS, the kinetic artwork has not yet been selected and staff is recommending it be relocated to the nature area of the Project, and selection deferred to that phase of the Civic Center project, as the intent of the piece is to represent the "Delta Breezes" in the region, which aligns with the environment envisioned for the nature area of the project. In addition the current placement of the piece is adjacent to the dancing fountain which is already a kinetic amenity; and

WHEREAS, the \$100,000 allocation to create a reflecting pool at the base of the iconic sculpture is not being utilized as estimates for the reflecting pool exceeded \$200,000. The current Civic Center public art budget is over-budget by \$70,000 with multiple cost centers such as the music sculpture, foundation engineering and installation, and lighting still pending. To balance the public art budget, staff are recommending reallocating the \$100,000 for the reflecting pool to general Civic Center art costs; and

WHEREAS, the Elk Grove Arts Commission reviewed and approved the recommendations at its August 16, 2018 meeting.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby approves the relocation of the iconic sculpture on the Civic Center Commons to the location generally depicted on Exhibit A, attached hereto and incorporated herein by reference; relocates the kinetic piece to the nature area of the Civic Center campus and defers its selection to that phase of the Civic Center project; and reallocates the \$100,000 for the reflecting pool at the base of the iconic sculpture to general Civic Center art costs.


