

RESOLUTION NO. 2018-214

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
ACCEPTING THE CORPORATION YARD PARKING AND ENTRY IMPROVEMENTS
(WCY005) AS COMPLETE; AND AUTHORIZING THE CITY ENGINEER TO
PREPARE AND THE CITY CLERK TO FILE THE NOTICE OF COMPLETION WITH
THE SACRAMENTO COUNTY RECORDER**

WHEREAS, on September 13, 2017, the City Council authorized the award of a construction contract to Western Engineering Contractors, Inc., for the Corporation Yard Parking and Entry Improvements Project (WCY005); and

WHEREAS, the Project provided for the construction of an employee parking area and the expansion of the Police Department parking area at the City's Corporation Yard, located near the corner of Union Parkway and Iron Rock Way; and

WHEREAS, Western Engineering Contractors, Inc. has completed the work in accordance with the terms and conditions of the contract documents for the Project; and


WHEREAS, if no liens or claims have been filed within thirty-five (35) days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to Western Engineering Contractors, Inc.; and

WHEREAS, post construction work is typically completed within one hundred twenty (120) days of the City Clerk filing the Notice of Completion with the Sacramento County Recorder and then all invoices can be paid, any remaining project budget authority would be adjusted to zero.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Accepts the Corporation Yard Parking and Entry Improvements Project (WCY005) as complete;
- 2) Authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder; and
- 3) Authorizes staff to amend the Annual Budget and Capital Improvement Program by reducing the remaining project budget authority to zero and returning any remaining funds back to their respective fund.
