

RESOLUTION NO. 2018-231

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
ACCEPTING THE PAVEMENT RESURFACING 2018 PROJECT (WPR018) AS
COMPLETE; AUTHORIZING THE CITY ENGINEER TO PREPARE AND THE CITY
CLERK TO FILE THE NOTICE OF COMPLETION WITH THE SACRAMENTO
COUNTY RECORDER; AND AUTHORIZING STAFF TO AMEND THE ANNUAL
BUDGET AND CAPITAL IMPROVEMENT PROGRAM**

WHEREAS, on June 13, 2018, the City Council authorized the award of a construction contract to American Pavement Systems, Inc. for the Resurfacing 2018 Project (WPR018); and

WHEREAS, the Project provided for the construction to place slurry seal, micro-surfacing and striping on various streets throughout the City; and

WHEREAS, American Pavement Systems, Inc. has completed the work in accordance with the terms and conditions of the contract documents for the Project; and


WHEREAS, if no liens or claims have been filed within thirty-five (35) days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to American Pavement Systems, Inc.; and

WHEREAS, post-construction work is typically completed within one hundred twenty (120) days of the City Clerk filing the Notice of Completion with the Sacramento County Recorder and then all invoices can be paid, any remaining project budget authority would be transferred.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Accepts the Pavement Resurfacing 2018 Project (WPR018) as complete;
- 2) Authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder; and
- 3) Authorizes staff to amend the Annual Budget and Capital Improvement Program by transferring any remaining funds to the 2019 Pavement Slurry Seal and Resurfacing Project (WPR019) and/or the Pavement Rehabilitation 2019 Project (WPR022).


