A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH THE FORMAL REQUEST FOR PROPOSAL PROCESS PURSUANT TO ELK GROVE MUNICIPAL CODE CHAPTER 3.42.188(B) (3) AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SECOND AMENDMENT TO THE CONTRACT WITH ROEBBELEN CONSTRUCTION MANAGEMENT SERVICES, INC. FOR SERVICES RELATED TO THE AQUATICS/COMMONS AND COMMUNITY CENTER PROJECTS INCREASING THE TOTAL AMOUNT BY \$508,000, FOR A TOTAL CONTRACT COMPENSATION AMOUNT OF \$2,552,365

WHEREAS, The City contracted with Roebbelen Construction Management Services, Inc. ("RCMS") in 2016 to provide construction management services for the Aquatics/Commons and Community Center projects ("Projects"); and

WHEREAS, the scope and fee assumed efficiencies from the overlapping construction of the two Projects; and

WHEREAS, it was assumed that the Aquatics/Commons project would start in April 2017 and the Community Center project would finish in November 2018; and

WHEREAS, the actual start date for the Aquatics/Commons was May 2017 while the Community Center is expected to be completed in summer 2019; and

WHEREAS, due to the schedule being extended eight months, RCMS will need an amendment to their existing contract

WHEREAS, for the reasons presented, pursuing competitive proposals for the proposed services is not in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby dispenses with the formal request for proposals process pursuant to Elk Grove Municipal Code section 3.42.140(B)(3) and authorizes the City Manager to execute the second amendment to the contract with Roebbelen Construction Management Services, Inc. for services related to the Aquatics/Commons and Community Center projects increasing the total contract amount by \$508,000 for a total contract compensation amount of \$2,552,365.
