## **RESOLUTION NO. 2019-008**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT FOR PROFESSIONAL ENGINEERING SERVICES WITH MARK THOMAS AND COMPANY, INC. FOR THE LAGUNA CREEK TRAIL AND BRUCEVILLE ROAD SAFE ROUTES TO SCHOOL IMPROVEMENTS PROJECT (WTL019) IN AN AMOUNT NOT TO EXCEED \$846,252

WHEREAS, the City of Elk Grove applied for and was awarded Federal funds to augment local funds for the delivery of the Laguna Creek Trail and Bruceville Road Safe Routes to School Improvements Project (Project); and

WHEREAS, the Project is included in the Sacramento Area Council of Governments (SACOG) Metropolitan Transportation Improvement Program (MTIP); and

WHEREAS, staff implemented a formal selection process in accordance with the City's purchasing guidelines, and State, and federal law; and

WHEREAS, TRC Engineers, Inc. was determined to be the first most qualified firm; and

WHEREAS, the City was not able to negotiate a Professional Services Agreement with TRC Engineers, Inc.; and

WHEREAS, Mark Thomas and Company, Inc. (Mark Thomas) was determined to be the second most qualified firm; and

WHEREAS, the City has negotiated a Professional Services Agreement with Mark Thomas to provide the required services; and

WHEREAS, the term of the Contract will be for five (5) years; and

WHEREAS, the Project (WTL019) (Project) is included in the 2018-2023 Capital Improvement Program; and

WHEREAS, the Project is included in the approved Fiscal Year 2018-2019 Budget.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a contract with Mark Thomas and Company, Inc. in an amount not to exceed \$846,252 for Professional Engineering Services for the Laguna Creek Trail and Bruceville Road Safe Routes to School Improvements Project (WTL019) in substantially the form presented, and subject to approval as to form by the City Attorney.
