A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH THE FORMAL REQUEST FOR PROPOSAL PROCEDURES PURSUANT TO ELK GROVE MUNICIPAL CODE SECTION 3.42.188(B)(3) AND AUTHORIZING THE CITY MANAGER TO EXECUTE CONTRACTS AND **NECESSARY AGREEMENTS FOR A THREE YEAR AGREEMENT WITH DATA** MANAGEMENT, INC., AND SUPERION LLC FOR IMPLEMENTING TIMECLOCK **PLUS SOFTWARE** 

WHEREAS, TimeClock Plus, a software product offered by Data Management, Inc. ("DMI"), is a robust timecard and scheduling system that will accommodate the City's various groups of employees to streamline processes into one system; and

WHEREAS, TimeClock Plus is authorized by Superion, LLC, the City's current citywide software provider, to access the necessary database to integrate with the City's payroll system; and

WHEREAS, TimeClock Plus will be an authorized third party product, and City will pay Superion for the DMI product and services; Superion in turn will pay DMI in accordance with the agreements described herein; and

WHEREAS, for the reasons presented, seeking competitive proposals for the subject services is not in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby dispenses with the formal request for proposal procedures pursuant to Elk Grove Municipal Code section 3.42.188(B)(3) and authorizes the City Manager to execute contracts and necessary agreements for a three year agreement with Data Management, Inc., to purchase TimeClock Plus, a time tracking and scheduling software, through the City's current Superion contract.

NOW, THEREFORE, BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby dispenses with the formal request for proposal procedures pursuant to Elk Grove Municipal Code section 3.42.188(B)(3) and authorizes the City Manager to execute contracts and necessary agreements with Superion LLC to allow the TimeClock Plus software to connect to City's payroll software.
