

**RESOLUTION NO. 2019-059**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
APPROVING THE ANIMAL CARE CENTER ARTWORK SELECTED BY THE  
REVIEW PANEL AND AUTHORIZING THE CITY MANAGER TO EXECUTE  
CONTRACTS WITH THE RESPECTIVE ARTISTS**

**WHEREAS**, the City Council adopted Resolution No. 2018-094 to dispense with the standard request for proposal process and allow for a request for qualifications/request for proposals process for public art projects; and

**WHEREAS**, the Animal Care Center artwork is the first project to utilize this process, and the Animal Care Center artwork consists of an exterior sculpture, an interior artwork behind the reception desk, and sequenced wall hangings along the adoption hallway; and

**WHEREAS**, the Review Panel met on December 17, 2018, to review the 53 initial submissions, and selected 10 artists to prepare proposals that were presented to the Review Panel on March 11, 2019; and


**WHEREAS**, the Review Panel unanimously selected the three proposals to present to City Council for consideration for the Animal Care Center artwork, and the Arts Commission unanimously approved the selection of artwork at its March 21, 2019 meeting; and

**WHEREAS**, all three of the selected artists are based in the Sacramento region and have substantial bodies of work that have been featured in galleries, museums, and have produced public art; and

**WHEREAS**, the selected artists are Gale Hart for the exterior sculpture, Robert Orbal for the interior artwork behind the reception desk, and Susan Silvester for the sequenced wall hangings along the dog adoption hallway.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby approves the selected artwork for the Animal Care Center and authorizes the City Manager to execute contracts with the respective artists in substantially the form presented in an amount not to exceed \$110,000 for the exterior sculpture, \$42,000 for the interior lobby artwork, and \$36,000 for the interior sequenced wall hangings.




