A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO APPLY FOR FISCAL YEAR 2018-19 LOW
CARBON TRANSIT OPERATIONS PROGRAM (LCTOP) FUNDS, IN THE AMOUNT
OF \$340,916, FOR THE CONSTRUCTION OF ELECTRIC INFRASTRUCTURE THAT
WOULD SUPPORT A ZERO EMISSION BUS FLEET, AND AUTHORIZING THE CITY
MANAGER TO ACT AS THE AUTHORIZING AGENT FOR THE PURPOSE OF
EXECUTING ALL REQUIRED DOCUMENTS FOR THE RECEIPT AND
ADMINISTRATION OF LCTOP FUNDS

WHEREAS, the City of Elk Grove is an eligible project sponsor and may receive state funding from the Low Carbon Transit Operations Program (LCTOP) now or sometime in the future for transit projects; and

WHEREAS, the statutes related to state-funded transit projects require a local or regional implementing agency to abide by various regulations; and

WHEREAS, Senate Bill 862 (2014) named the Department of Transportation (Department) as the administrative agency for the LCTOP; and

WHEREAS, the Department has developed guidelines for the purpose of administering and distributing LCTOP funds to eligible project sponsors (local agencies); and

WHEREAS, the City of Elk Grove wishes to delegate authorization to execute these documents and any amendments thereto to the City Manager; and

WHEREAS, the City of Elk Grove wishes to implement the LCTOP project listed above.

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Elk Grove agrees to comply with all conditions and requirements set forth in the Certification and Assurances document and applicable statutes, regulations and guidelines for all LCTOP funded transit projects; and

BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove authorizes the City Manager to execute all required documents of the LCTOP program with the California Department of Transportation, act as the Authorizing Agent for the purpose of executing all required documents for the receipt and administration of LCTOP funds, and submit the following project nomination and allocation request to the Department for FY2018-19 LCTOP funds:

Project Name: Zero emission infrastructure for Elk Grove's Transit System Amount of LCTOP funds requested: \$340,916

Short description of project: Construction of electric infrastructure that would support zero emission bus fleet, to begin implementation of California Air Resources Board's (CARB) Innovative Clean Transit Regulation Plan.

Contributing Sponsor: Sacramento Area Council of Governments (SACOG)

BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove authorizes the City Manager to make any necessary revisions to Transit's fiscal year budget in order to address this funding upon receipt.
