**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
ACCEPTING THE LED REPLACEMENT LAMP UPGRADE PROJECT AS
COMPLETE; AUTHORIZING THE CITY ENGINEER TO PREPARE AND THE CITY
CLERK TO FILE THE NOTICE OF COMPLETION WITH THE SACRAMENTO
COUNTY RECORDER**

WHEREAS, on November 14, 2018 the City Council authorized the City Manager to execute a contract to Mark Jungkeit dba Jungkeit Electrical and General Contracting of Elk Grove; and

WHEREAS, the Project provided for the purchase and installation of energy conserving Light Emitting Diode (LED) lamps for City Facilities; and

WHEREAS, Mark Jungkeit dba Jungkeit Electrical and General Contracting of Elk Grove, has completed the work in accordance with the terms and conditions of the contract documents for the Project; and

WHEREAS, Staff has determined that the work is complete; and

WHEREAS, if no liens or claims have been filed within thirty-five (35) days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to Mark Jungkeit dba Jungkeit Electrical and General Contracting of Elk Grove.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Accepts the LED Replacement Lamp Upgrade Project as complete; and
- 2) Authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.




