

RESOLUTION NO. 2019-085

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE ACCEPTING THE SIDEWALK INFILL PROJECT 2018 (EAST STOCKTON BOULEVARD AND LAGUNA BOULEVARD)(WAC032) (REBID) AS COMPLETE; AUTHORIZING THE CITY ENGINEER TO PREPARE AND THE CITY CLERK TO FILE THE NOTICE OF COMPLETION WITH THE SACRAMENTO COUNTY RECORDER; AND AUTHORIZING STAFF TO AMEND THE ANNUAL BUDGET AND CAPITAL IMPROVEMENT PROGRAM BY REDUCING THE REMAINING PROJECT BUDGET AUTHORITY TO ZERO AND RETURNING ANY REMAINING FUNDS BACK TO THEIR RESPECTIVE FUND(S)

WHEREAS, on October 24, 2018, the City Council authorized the award of a construction contract to B & M Builders, Inc., for the Sidewalk Infill Project 2018 (East Stockton Boulevard and Laguna Boulevard)(WAC032) (Rebid) and

WHEREAS, the Project included construction of pedestrian paths along the east side of East Stockton Boulevard north of Banff Vista Drive and along the north side of Laguna Boulevard west of Big Horn Boulevard; and

WHEREAS, B & M Builders, Inc. has completed the work in accordance with the terms and conditions of the contract documents for the Project; and


WHEREAS, if no liens or claims have been filed within 35 days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to B & M Builders, Inc., and

WHEREAS, post construction work is typically completed within 120 days of the City Clerk filing the Notice of Completion with the Sacramento County Recorder and then all invoices can be paid.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:


- 1) Accepts the Sidewalk Infill Project 2018 (East Stockton Boulevard and Laguna Boulevard)(WAC032) (Rebid) as complete,
- 2) Authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder, and
- 3) Authorizes staff to amend the Annual Budget and Capital Improvement Program by reducing the remaining project budget authority to zero and returning any remaining funds back to their respective fund(s)


