**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO ENTER INTO A MEMORANDUM OF  
UNDERSTANDING AND COOPERATIVE AGREEMENT WITH THE CAPITAL  
REGION SMALL BUSINESS DEVELOPMENT CENTER TO CONTINUE THE SOUTH  
SACRAMENTO COUNTY SMALL BUSINESS DEVELOPMENT CENTER  
AT ELK GROVE CITY HALL**

**WHEREAS**, the goals of the City Council include fostering a vibrant and diverse economy oriented toward growing jobs, while also providing regional leadership through collaboration; and

**WHEREAS**, the City of Elk Grove supports our local businesses that create jobs, boost our economy, and preserve our neighborhoods; and

**WHEREAS**, the City of Elk Grove seeks to continue to provide free support services assisting entrepreneurs in starting a new business or in expanding their existing business in partnership with the Capital Region Small Business Development Center; and

**WHEREAS**, staff has determined that the Capital Region Small Business Development Center is the sole entity for providing services funded by the Small Business Administration in the Greater Sacramento Region, and that, given the positive outcomes of the program to date, seeking competitive bids for the subject services is not in the best interest of the City.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove finds that entering into the Memorandum of Understanding and Cooperative Agreement is in the best interest of the City and authorizes the City Manager to enter into a Memorandum of Understanding and Cooperative Agreement with the Capital Region Small Business Development Center to continue a south Sacramento County Small Business Development Center at Elk Grove City Hall.
