A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH THE FORMAL REQUEST FOR PROPOSAL PROCEDURES PURSUANT TO ELK GROVE MUNICIPAL CODE SECTION 3.42.140(B)(3), AND AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH OPENCOUNTER ENTERPRISES, INC. FOR HOSTING AND MAINTENANCE OF AN ONLINE PORTAL FOR ZONING AND BUSINESS PERMITTING AND FEE INFORMATION FOR A MAXIMUM OF THREE YEARS AND A TOTAL NOT-TO-EXCEED AMOUNT OF \$116,250

WHEREAS, economic development efforts are critical for the City of Elk Grove to ensure a vibrant, healthy, and diverse local economy; and

WHEREAS, an online portal that allows citizens, developers, and businesses to obtain reliable and timely information about zoning, permits, and fees greatly enhances the City's economic development efforts; and

WHEREAS, OpenCounter Enterprises, Inc. developed and customized such a product for the City and is the current provider; and

WHEREAS, staff has determined that formal solicitation of proposals for the proposed services will not yield results more advantageous to the City; and

WHEREAS, for the reasons presented, pursuing a formal request for proposal process (RFP) for the proposed services is not in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby dispenses with the competitive bid process pursuant to Elk Grove Municipal Code section 3.42.140(B)(3), and authorizes the City Manager to execute a contract with OpenCounter Enterprises, Inc., in substantially the form presented, for hosting and maintenance of an online portal for zoning, business permitting and fee information, for a maximum of three years and a total contract amount not-to-exceed \$116,250.
