

RESOLUTION NO. 2019-148

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH THE FORMAL BIDDING REQUIREMENTS PER ELK GROVE MUNICIPAL CODE SECTION 3.42.180(B)(3) AND AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH PERFORMANCE AUTOMOTIVE GROUP, INC., A CALIFORNIA CORPORATION DBA ELK GROVE FORD FOR THE PURCHASE OF FIFTEEN REPLACEMENT POLICE VEHICLES AND THREE ADDITIONAL POLICE VEHICLES IN AN AMOUNT NOT-TO-EXCEED \$720,100

WHEREAS, the City of Elk Grove's Fleet division maintains all City vehicles and procures replacements when necessary; and

WHEREAS, the City's Fleet division has identified fourteen police vehicles and one wrecked vehicle that have reached their useful life of City service and require replacement; and

WHEREAS, the Elk Grove Police Department has increased its field service staffing levels by four sworn officers this fiscal year, therefore requiring two additional patrol vehicles to be added to the fleet; and

WHEREAS, the Elk Grove Police Department was awarded a partnership with the Sacramento County Division of Behavioral Health to establish a mobile crisis support team, therefore requiring one additional patrol vehicle bringing the total number of additional patrol vehicles required this fiscal year to three; and

WHEREAS, the State of California opened a competitive bidding process for the purchase of police patrol utility vehicles; and

WHEREAS, Performance Automotive Group Inc., a California Corporation dba Elk Grove Ford (Elk Grove Ford) has been asked to match the prices of the State issued contract to purchase the vehicles in Elk Grove; and

WHEREAS, Elk Grove Ford agreed to match the prices posted in the State of California's large quantity contract award, which was competitively bid, thus the City is receiving a competitive price; the expenditures of staff time and money to compile the necessary bid documents for a small quantity of vehicles will not likely result in a better price or an outcome more advantageous to the City; and Elk Grove Ford is located within the City of Elk Grove and therefore one percent of every taxable sale will return to the City; and


WHEREAS, for the reasons presented, it is not in the best of interest of the City to conduct formal bidding for the purchase of the subject vehicles; and

WHEREAS, Fleet Services, Risk Management and the Police Department have sufficient funding identified in the 2019-20 fiscal year operating budget for this purchase.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby determines that formal competitive bidding is not in the best interest of the City for the subject vehicles and hereby dispenses with the formal bid requirements pursuant to the Elk Grove Municipal Code Section 3.42.180(B)(3) for a contract for the purchase of the subject vehicles; and

BE IT FURTHER RESOLVED that the City Manager is hereby authorized to execute a contract with Performance Automotive Group, Inc., a California corporation doing business as Elk Grove Ford for the purchase of eighteen Ford police patrol interceptor utility vehicles, in an amount not-to-exceed \$720,100.


