

RESOLUTION NO. 2019-138

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE THE FIRST AMENDMENT TO
CONSULTANT CONTRACT WITH WEST INTERACTIVE SERVICES CORPORATION
FOR WEBSITE HOSTING SERVICES**

WHEREAS, on July 23, 2014, the City entered into a contract with Intrafinity, Inc. dba Intrafinity (C-14-2197) ("Contract") to provide website hosting services, which includes one three-year extension option; and

WHEREAS, in May of 2015, Intrafinity, Inc. dba CivicLive (Intrafinity) merged with and into West Interactive Services Corporation (WISC), at which time WISC assumed all rights, privileges, obligations, and liabilities of Intrafinity, including the operations pertaining to the services covered under the Contract. As a result of this transaction, Intrafinity assigned its obligations under the Contract to West Interactive Services Corporation; and

WHEREAS, the City and Intrafinity agree to WISC's assumption of the Contract;
and

WHEREAS, WISC has performed required services to the satisfaction of the City and its customers; and

WHEREAS, the City finds it is in its best to exercise its option to extend the Contract for an additional three-year term.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a First Amendment to the Consultant Contract with West Interactive Services Corporation, in substantially the form presented, recognizing the assignment and assumption of the contractual obligations by WISC, and exercising the option to extend the Contract term for an additional three years.
