RESOLUTION NO. 2019-155

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE FINDING THE BOND ROAD PAVEMENT REHABILITATION WTC015 PROJECT (OM1906) EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT AND APPROVING THE PROJECT; AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSTRUCTION CONTRACT WITH SIERRA ASPHALT, INC. FOR THE PROJECT IN THE AMOUNT OF \$458,000; AUTHORIZING THE CITY ENGINEER TO APPROVE CHANGE ORDERS NOT-TO-EXCEED \$68,000; AND AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSTRUCTION CONTRACT WITH THE SECOND LOWEST RESPONSIVE BIDDER IF THE FIRST LOWEST RESPONSIVE BIDDER DOES NOT MEET FILING OBLIGATIONS

- WHEREAS, the Bond Road Pavement Rehabilitation WTC015 Project (OM1906) (Project) includes asphalt concrete (AC) base repairs along Bond Road to be completed in advance of the median improvements work to be bid and awarded at a future date; and
- WHEREAS, the next phase of work, Bond Road Median Improvements and Resurfacing Project (WTC015) will be advertised to bid and constructed in 2020; and
- **WHEREAS**, the Project Work is being bid in two phases in order to provide a better environment for lower bid prices to be received; and
- **WHEREAS**, an invitation to bid was duly advertised on June 12, 2019, and June 19, 2019, and bids were opened on July 2, 2019; and
- **WHEREAS**, Sierra Asphalt, Inc. was determined to be the responsible bidder submitting the lowest responsive bid; and
- **WHEREAS**, Sierra Nevada Construction, Inc. was determined to be the responsible bidder submitting the second lowest responsive bid; and
- WHEREAS, the Project is a project under California Environmental Quality Act (Section 21000 et seq. of the Public Resources Code, hereinafter referred to as CEQA) which requires that cities consider the environmental consequences of their actions before approving a project; and
- WHEREAS, Section 15301(c) (Class I: Existing Facilities) of the State CEQA Guidelines (Chapter 3 of Division 6 of Title 14 of the California Code of Regulations) provides an exemption from CEQA for projects involving the minor alteration of existing public or private facilities when the alteration involves negligible or no expansion of an existing use. As the Project involves rehabilitation to existing pavement, restriping of travel lanes, and will not include widening of the roadway and will not include creation of any new through travel lanes. For these reasons, the Project qualifies for the identified exemption; and
- **WHEREAS**, the Project is included in the approved Fiscal Year 2019-24 Capital Improvement Program and is budgeted with funds in the approved Fiscal Year 2019-20 Budget.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- Finds the Project exempt from CEQA pursuant to Categorical Exemption Class
 Existing Facilities, per CEQA Guidelines 15301(c), and approves the Project;
 and
- 2) Authorizes the City Manager to execute a construction contract with Sierra Asphalt, Inc. for the Bond Road Pavement Rehabilitation Project WTC015 (OM1906) in the amount of \$458,000 upon receipt of all required bonds and insurance and the approval of such bonds and insurance by the City Attorney; and,
- 3) Authorizes the City Engineer to approve change orders not-to-exceed \$68,000; and,
- 4) Authorizes the City Manager to execute a construction contract with the second lowest responsive bidder, Sierra Nevada Construction, Inc., if, Sierra Asphalt, Inc., does not meet filing obligations.
