(FM1705) AS COMPLETE; AUTHORIZING THE CITY ENGINEER TO PREPARE AND
THE CITY CLERK TO FILE THE NOTICE OF COMPLETION WITH THE
SACRAMENTO COUNTY RECORDER; AND AUTHORIZING STAFF TO AMEND
THE ANNUAL BUDGET AND CAPITAL IMPROVEMENT PROGRAM BY REDUCING
THE REMAINING PROJECT BUDGET AUTHORITY TO ZERO AND RETURNING
ANY REMAINING FUNDS BACK TO THEIR RESPECTIVE FUND(S)

- **WHEREAS**, the Real Time Information Center Project (FM1705) (Project) was completed in two phases; and
- **WHEREAS**, the Real Time Information Center Phase 1 Project (FM1705) (Project) resulted in the remodeling of two existing office spaces into one larger room, to house the second phase of the Project; and
- WHEREAS, the Real Time Information Center Phase 2 (FM1705) (Project) provided procurement and installation of necessary hardware and software for the operation of the Real Time Information Center including a 16-foot video monitor wall, display processor and audio digital signal processor controller with appropriate volume and source control to monitor real time police department video and data; and
- WHEREAS, on February 13, 2019, the City Council authorized the award of a construction contract to Signal Perfection, Ltd., for the Real Time Information Center Phase 2 Project (FM1705); and
- WHEREAS, the Project resulted in the installation of necessary hardware and software for the operation of the Real Time Information Center and included procurement and installation of a 16-foot video monitor wall, display processor and audio digital signal processor controller with appropriate volume and source control to monitor real time police department video and data; and
- **WHEREAS**, Signal Perfection, Ltd., has completed the work in accordance with the terms and conditions of the contract documents for the Project; and
- **WHEREAS**, if no liens or claims have been filed within thirty-five (35) days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to Signal Perfection, Ltd.; and
- **WHEREAS**, post construction work is typically completed within 120 days of the City Clerk filing the Notice of Completion with the Sacramento County Recorder and then all invoices can be paid.
- **NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby:
 - 1) Accepts the Real Time Information Center Phase 2 Project (FM1705) as complete;

- 2) Authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder; and
- 3) Authorizes staff to amend the Annual Budget and Capital Improvement Program by reducing the remaining project budget authority to zero and returning any remaining funds back to their respective fund(s).
