A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH THE FORMAL REQUEST FOR PROPOSAL PROCEDURES PURSUANT TO ELK GROVE MUNICIPAL CODE SECTION 3.42.140 (B)(3), AND AUTHORIZING THE CITY MANAGER TO EXECUTE CONTRACTS FOR EMPLOYMENT INVESTIGATION SERVICES WITH ELLIS MAKUS LLP AND BOUTIN JONES, INC. FOR A TERM OF TWO YEARS, IN AN AMOUNT NOT TO EXCEED \$100,000 PER CONTRACT WITH A NOT TO EXCEED AMOUNT OF \$200,000 COMBINED

WHEREAS, the City Council of the City of Elk Grove recognizes the periodic need to utilize employment investigation services; and

WHEREAS, utilizing an outside firm or individual consultant can minimize both the perception of bias and the risk of actual or perceived conflict of interest on the part of an internal investigator; and

WHEREAS, the City has been satisfied with the services provided by both Ellis Makus LLP and Boutin Jones, Inc. over the past prior contract terms; and

WHEREAS, both prior contracts, awarded through a competitive request for proposal process, recently expired, and the City desires to continue to work with both firms; and

WHEREAS, for the reasons presented, pursuing a further competitive proposal process is not in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby dispenses with the formal request for proposal procedures pursuant to Elk Grove Municipal Code Section 3.42.140 (B)(3), and authorizes the City Manager to execute contracts for employment investigation services with Ellis Makus LLP and Boutin Jones, Inc. for a term of two years, in an amount not to exceed \$100,000 per contract with a not to exceed amount of \$200,000 combined.
