

RESOLUTION NO. 2019-217

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE A BILLING AGREEMENT  
FOR SMALL CELL CONNECTIONS TO CITY STREETLIGHTS WITH THE  
SACRAMENTO MUNICIPAL UTILITY DISTRICT**

**WHEREAS**, at the August 28, 2019 City Council meeting, the City Council approved a Master License Agreement (MLA) between the City of Elk Grove and New Cingular Wireless PCS, LLC (dba AT&T Mobility) (AT&T) for Small Cell Wireless Communications Facilities: and

**WHEREAS**, the MLA allows attachment of small cell devices to designated streetlight poles owned by the City, subject to the terms and conditions of the MLA; and


**WHEREAS**, the MLA requires AT&T to pay for all electric service necessary for the small cell facilities: and

**WHEREAS**, the Sacramento Municipal Utility District (SMUD) sets the requirements for connection of these devices to electric service: and

**WHEREAS**, SMUD has requested that the City enter into a Billing Agreement that will allow SMUD to bill AT&T and future telecommunication service providers directly for the use of electricity for unmetered streetlight service connections

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a Billing Agreement with the Sacramento Municipal Utility District (SMUD), in substantially the form presented, allowing SMUD to directly bill telecommunication service providers for electric service to power small cell wireless connections installed on City streetlights.
