

RESOLUTION NO. 2020-003

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE ACCEPTING THE BRUCEVILLE ROAD AND POPPY RIDGE ROAD/QUAIL RUN LANE INTERSECTION SIGNALIZATION (WTR011) PROJECT AS COMPLETE; AUTHORIZING THE CITY ENGINEER TO PREPARE AND THE CITY CLERK TO FILE THE NOTICE OF COMPLETION WITH THE SACRAMENTO COUNTY RECORDER; AND AUTHORIZING STAFF TO AMEND THE ANNUAL BUDGET AND CAPITAL IMPROVEMENT PROGRAM BY REDUCING THE REMAINING PROJECT BUDGET AUTHORITY TO ZERO AND RETURNING ANY REMAINING FUNDS BACK TO THEIR RESPECTIVE FUND(S)

WHEREAS, on February 13, 2019, the City Council authorized the award of a construction contract to Tim Paxin's Pacific Excavation, Inc., for the Bruceville Road and Poppy Ridge Road/Quail Run Lane Intersection Signalization Project (WTR011); and

WHEREAS, the Project resulted in construction of a traffic signal at Bruceville Road and Poppy Ridge Road/Quail Run Lane with signal interconnection; improvements also included construction of a concrete island in the northeast corner of the intersection, and signing and pavement marking improvements at the intersection; and

WHEREAS, Tim Paxin's Pacific Excavation, Inc. has completed the work in accordance with the terms and conditions of the contract documents for the Project; and

WHEREAS, if no liens or claims have been filed within thirty-five (35) days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to Tim Paxin's Pacific Excavation, Inc.; and

WHEREAS, post construction work is typically completed within one hundred twenty (120) days of the City Clerk filing the Notice of Completion with the Sacramento County Recorder and then all invoices can be paid.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:


- 1) Accepts the Bruceville Road and Poppy Ridge Road/Quail Run Lane Intersection Signalization Project (WTR011) as complete;
- 2) Authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder; and
- 3) Authorizes staff to amend the Annual Budget and Capital Improvement Program by reducing the remaining project budget authority to zero and returning any remaining funds back to their respective fund(s).
