A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AMENDING THE FISCAL YEAR 2019-20 BUDGET FOR THE ELK GROVE LIBRARY SECOND FLOOR STRUCTURAL REPAIR AND FLOORING REPLACEMENT PROJECT (FM1806) (CEQA EXEMPT)

WHEREAS, the Elk Grove Library Second Floor Structural Repair and Flooring Replacement Project (FM1806) (Project) will result in all Work involved in the structural repair of the second floor and second floor flooring replacement at the Elk Grove Library, 8900 Elk Grove Boulevard, as well as replacement of existing resilient flooring; and

WHEREAS, the Project is a project under California Environmental Quality Act (Section 21000 et seq. of the Public Resources Code, hereinafter referred to as CEQA) which requires that cities consider the environmental consequences of their actions before approving a project; and

WHEREAS, CEQA Guidelines 15301(d) (Existing Facilities) state that a project is exempt from CEQA review if it includes restoration or rehabilitation of deteriorated or damaged structures to meet current standards of public health and safety, unless the damage was substantial and resulted from an environmental hazard such as an earthquake, landslide, or flood. The Project would involve internal repairs to rehabilitate an existing joist. An additional project component includes replacing a deteriorated section of 2nd floor resilient flooring which extends from the area of the detached joist to the stairwell. These types of repairs are not considered substantial as they involve rehabilitation of a single joist and replacement of existing flooring. Additionally, the repair is needed due to tenant improvements implemented over 10 years ago and not as a result of an environmental hazard. As such, the Project qualifies for the identified exemption and a Notice of Exemption will be filed with the Sacramento County Clerk; and

WHEREAS, the Project is included in the approved Fiscal Year 2019-24 Capital Improvement Program and is budgeted with funds in the approved Fiscal Year 2019-20 Budget.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes an amendment to the Fiscal Year 2019-20 Budget by adding \$145,000 from the Library Ownership/Maintenance (Fund 280) fund to the Elk Grove Library Second Floor Structural Repair and Flooring Replacement Project (FM1806), a minor public works project.
