## **RESOLUTION NO. 2020-015**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY ENGINEER TO APPROVE CONTRACT CHANGE ORDERS FOR THE ELK GROVE AQUATICS AND CIVIC CENTER COMMONS PROJECT (WCC002) IN AN AMOUNT NOT TO EXCEED \$2,870,978, AN INCREASE OF \$71,000

WHEREAS, on March 29, 2017, the City Council authorized the award of a construction contract to Arntz Builders, Inc. (Contractor) for the Aquatics Center/ Commons Project in the amount of \$30,754,886 and authorized the City Engineer to approve change orders not-to-exceed \$1,537,744; and

WHEREAS, on May 23, 2018, the City Council authorized an increase in change order authority of \$399,000 to fund the addition of four Electric Vehicle Fast Chargers to the Project, bringing the total change order authority to \$1,936,744; and

WHEREAS, on December 12, 2018, the City Council authorized an increase in change order authority of \$863,234 to fund a variety of change orders including design changes after award, building permit impacts, and facility enhancements bringing the total change order authority to \$2,799,978; and

WHEREAS, additional construction contract change orders have been identified and an additional increase in change order authority of \$71,000 is needed; and

WHEREAS, the existing Project budget has sufficient funding to cover these costs.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Engineer to approve change orders in a total amount not-to-exceed \$2,870,978 for the Aquatics and Civic Center Commons Project.
