

**RESOLUTION NO. 2020-026**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH APPLE, INC. ACCEPTING A DONATION ON BEHALF OF THE ELK GROVE POLICE DEPARTMENT TO BE USED FOR DISPATCH EQUIPMENT AND TRAINING IN THE AMOUNT OF APPROXIMATELY \$98,600, AMENDING THE FISCAL YEAR 2019-20 BUDGET BY INCREASING THE POLICE DEPARTMENT'S REVENUE AND EXPENDITURE BUDGET BY THE SAME AMOUNT, AND ACCEPTING A DONATION OF PRODUCTS VALUED AT APPROXIMATELY \$131,075 FOR A TOTAL CONTRIBUTION OF APPROXIMATELY \$229,675**

**WHEREAS**, the Elk Grove Police Department's Dispatch Center serves the citizens of Elk Grove 24 hours per day, seven days per week, 365 days per year; and

**WHEREAS**, Dispatchers utilize technology and equipment in a high-stress environment in order to respond to the needs of the community; and

**WHEREAS**, Apple, Inc. desires to donate funds and equipment to support the Dispatch Center and its service to the Elk Grove community; and

**WHEREAS**, all purchases made with the donated funds will comply with Elk Grove Municipal Code Chapter 3.42.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute an agreement with Apple Inc., in a form approved by the City Attorney:

- 1) Accepting a donation from Apple, Inc on behalf of the Elk Grove Police Department (EGPD) to be used for dispatch equipment and training in the amount of approximately \$98,600;
- 2) Amending the Fiscal Year 2019-20 budget by increasing the Police Department's revenue and expenditure budget by the same amount; and
- 3) Accepting a donation of products valued at approximately \$131,075.


