A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT BETWEEN THE
CITY AND THE COSUMNES COMMUNITY SERVICES DISTRICT TO UTILIZE THE
CITY'S APPRAISAL SERVICES FOR CALCULATING PARKLAND IN-LIEU FEES

WHEREAS, in September of 2019, the City of Elk Grove (City) and the Cosumnes Community Services District (CCSD) entered into a Memorandum of Understanding (MOU) related to the development of park and recreation facilities within the City; and

WHEREAS, the CCSD currently administers its own appraisal services for calculating parkland in-lieu fees pursuant to Section 22.40.040.C of the Elk Grove Municipal Code (EGMC) for parks and recreation facilities exclusively owned, managed and/or planned by the CCSD; and

WHEREAS, the City administers appraisal services for calculating parkland in-lieu fees pursuant to EGMC Section 22.40.040.B for "New Park Facilities" as identified in Exhibit A of the MOU; and

WHEREAS, to obtain more accurate appraisals and provide consistency Citywide in the amounts calculated for parkland-in-lieu fees for new development, the CCSD has requested to utilize the City's appraisal services pursuant to EGMC Sections 22.40.040 B and 22.40.040.C; and

WHEREAS, this action does not constitute a project under State California Environmental Quality Act (CEQA) Guidelines as it is an administrative activity of governments that will not result in direct or indirect physical changes in the environment (CEQA Guidelines Section 15378(b)(5)), and therefore, no environmental review is required.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a Contract for Services with the CCSD for appraisal services in substantially the form presented.
