

RESOLUTION NO. 2020-063

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH AECOM
FOR THE LAGUNA WEST LEVEE GEOTECHNICAL INVESTIGATION PROJECT,
IN AN AMOUNT NOT TO EXCEED \$500,000**

WHEREAS, the City of Elk Grove has determined that there is a need to hire a consultant to provide geotechnical investigations and determine the structural integrity of the Laguna West Levee System; and

WHEREAS, in July 2019, Council directed staff to conduct a consultant selection process to select a firm to provide geotechnical investigations on the Laguna West Levee System; and

WHEREAS, staff prepared a Request for Proposals (RFP) for the Laguna West Levee Geotechnical Investigation Project; and

WHEREAS, a formal selection process was implemented in accordance with City provisions and AECOM has been determined as the most qualified firm; and

WHEREAS, staff has negotiated a Professional Services Agreement (Contract) with AECOM to provide the required services for the Project; and

WHEREAS, funding for the Project is programmed in the Capital Improvement Program (CIP) FY2019-2024 and FY2019-2020 Budgets.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a contract with AECOM, in substantially the form provided, for the Laguna West Levee Geotechnical Investigation Project in an amount not to exceed \$500,000.
