

**RESOLUTION NO. 2020-143**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE AMENDMENTS TO THE  
MEMORANDUMS OF UNDESTANDING (MOUs) BETWEEN THE CITY OF ELK  
GROVE AND THE CITIES OF SACRAMENTO AND GALT FOR REIMBURSEMENT  
OF COSTS AS THEY RELATE TO PARTICIPATION AT THE CITY OF ELK GROVE  
SPECIAL WASTE COLLECTION CENTER**

**WHEREAS**, The Special Waste Collection Center (SWCC) provides household hazardous waste (HHW) collection services to residents of Elk Grove and the entire South Sacramento County region; and

**WHEREAS**, as such, the City of Elk Grove has partnered with several jurisdictions, including the Cities of Sacramento and Galt, allowing their residents to utilize the SWCC for HHW disposal; and

**WHEREAS**, this regional concept is an important component of proper environmental stewardship in the region as it provides an easy and convenient method of HHW disposal for regional residents, thereby ensuring this waste is disposed of properly and does not create impacts to the environment; and

**WHEREAS**, the City entered into several memorandums of understanding (MOUs) with neighboring jurisdictions to ensure cost recovery when their residents use the SWCC; and

**WHEREAS**, the MOUs for the Cities of Sacramento and Galt will expire on June 30, 2020, and all jurisdictions have determined it is in the best interest of their residents to extend the MOUs; and

**WHEREAS**, the proposed amendments to the MOUs will extend each agreement for a period of three years.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute amendments to the MOUs between the City of Elk Grove and the Cities of Sacramento and Galt, in substantially the form presented, for participation at the Special Waste Collection Center, extending the term of each agreement for a period of three years.




