**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
DISPENSING WITH THE FORMAL REQUEST FOR PROPOSAL PROCEDURES
PURSUANT TO ELK GROVE MUNICIPAL CODE SECTION 3.42.140(B)(3) AND
AUTHORIZING THE CITY MANAGER TO EXECUTE A THREE-YEAR CONTRACT
WITH VAN SCOYOC ASSOCIATES, INC. FOR FEDERAL GOVERNMENT
RELATIONS SERVICES WITH A NOT-TO-EXCEED AMOUNT OF \$111,000**

WHEREAS, the City of Elk Grove (City) has contracted with Van Scoyoc Associates, Inc. (Van Scoyoc) since April 2006 to provide Federal Government Relations Services to the City; and

WHEREAS, Van Scoyoc is familiar with the goals and priorities of the City as well as the City's Congressional delegation and staffs; and

WHEREAS, Van Scoyoc has been working on the City's behalf in Washington, D.C. on many fronts over the last several years as described in the staff report; and

WHEREAS, for the reasons presented, pursuit of a formal solicitation process for the proposed contract is not in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Elk Grove hereby dispenses with the City's formal request for proposal procedures pursuant to Elk Grove Municipal Code Section 3.42.140(B)(3), and authorizes the City Manager to execute a three-year contract with Van Scoyoc Associates, Inc., in substantially the form presented, for Federal Government Relations Services in an amount not to exceed \$111,000.
