**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
EXPRESSING THE COUNCIL'S SUPPORT FOR A BALANCED RESPONSE BY  
LOCAL, STATE, AND FEDERAL AUTHORITIES TO THE COVID-19 GLOBAL  
PANDEMIC THAT PROTECTS THE HEALTH AND SAFETY OF OUR COMMUNITIES  
WHILE RECOGNIZING THE NEED TO MITIGATE THE ECONOMIC, SOCIAL AND  
OTHER HARDSHIPS ON BUSINESSES AND FAMILIES**

**WHEREAS**, personal responsibility such as social distancing and mask wearing is more sustainable and compassionate than punitive enforcement measures.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby expresses its support for a balanced response by local, state and federal authorities to the COVID-19 global pandemic that protects the health and safety of our communities, while recognizing the need to mitigate the economic, social, and other hardships imposed on businesses and families.
