

RESOLUTION NO. 2021-277

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE AN EVENT SPONSORSHIP
AGREEMENT WITH THE ELK GROVE YOUTH SPORTS FOUNDATION IN AN
AMOUNT NOT TO EXCEED \$76,342**

WHEREAS, the Elk Grove Youth Sports Foundation was awarded an event sponsorship grant (ESG) in FY2020-21 providing cash and in-kind support at a value of \$38,171 to host their annual Running of the Elk event on April 11, 2021; and

WHEREAS, the Elk Grove Youth Sports Foundation was forced to postpone the 2021 Running of the Elk event due to COVID-19 restrictions on large events; and

WHEREAS, the Elk Grove Youth Sports Foundation submitted a formal written request to roll over FY2020-21 grant funds in order to reschedule their 2021 event in October and still host their approved 2022 event in April 2022 at the same value, for a total grant amount of \$76,342 to sponsor both events in the same fiscal year; and

WHEREAS, the City has adequate funding allocated in the FY2021-22 Events budget to support both events.


NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute an Event Sponsorship Agreement with the Elk Grove Youth Sports Foundation in an amount not to exceed \$76,342 in substantially the form presented.


