A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE ESTABLISHING A RECORDS RETENTION POLICY FOR THE RISK MANAGEMENT DIVISION

WHEREAS, the Risk Management Division maintains records that pertain to the operation and administration of City government; and

WHEREAS, the responsible maintenance of the City's records includes adopting a policy for the retention and disposition of records; and

WHEREAS, California Government Code Section 34090 requires the legislative body to approve a policy for the disposition of records that are no longer required.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Adopts the Records Retention Policy for records maintained by the Risk Management Division, as consented to by the City Attorney in accordance with California Government Code Section 34090 et seq., and attached hereto as Exhibit A and incorporated herein by reference; and
- 2) Authorizes the Risk Management Division to employ technological methods to provide for the electronic storage and recovery of records in a trusted system, as provided by statute.
