

**RESOLUTION NO. 2022-242**

**ADOPT A RESOLUTION AUTHORIZING THE CITY MANAGER TO EXECUTE A MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF ELK GROVE AND CROWN CASTLE FIBER LLC REGARDING RAPID CONNECT INSTALLATION**

**WHEREAS**, On July 27, 2022, the City Council adopted a resolution (2022-187) authorizing the City Manager to execute a Master License Agreement with Crown Castle Fiber, LLC (Crown Castle) to facilitate the deployment of small cell communications devices at approved locations around the City of Elk Grove; and

**WHEREAS**, Crown Castle has developed a propriety method of installing fiber optic cable called Rapid Connect; and

**WHEREAS**, Rapid Connect installation method provides many potential benefits compared to traditional installation methods; and

**WHEREAS**, approval of the proposed Memorandum of Understanding ("MOU") would allow Crown Castle to use the Rapid Connect method of fiber optic cable installation in the City's right of way at the specific locations identified in the MOU; and

**WHEREAS**, prior to installation, Crown Castle will be required to submit encroachment permit applications for review and approval by the Public Works Director.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a Memorandum of Understanding between the City of Elk Grove and Crown Castle Fiber LLC regarding Rapid Connect installation in substantially the form presented.
