

RESOLUTION NO. 2022-249

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO ACCEPT GRANT FUNDING FOR AN
EDUCATIONAL BICYCLE SAFETY CAMPAIGN FOR YOUNG RIDERS FROM THE
CALIFORNIA OFFICE OF TRAFFIC SAFETY AND AMEND THE OFFICE OF
STRATEGIC PLANNING AND INNOVATION'S BUDGET TO APPROPRIATE GRANT
FUNDS UP TO THE AMOUNT OF \$100,000**

WHEREAS, the California Office of Traffic Safety's (OTS) mission is to effectively and efficiently administer traffic safety grant funds to reduce traffic deaths, injuries, and economic loss; and

WHEREAS, OTS provides grant funding opportunities to local agencies that will support and advance the mission of OTS; and

WHEREAS, the Office of Strategic Planning and Innovation desires to expand its promotion of bicycle safety using evidence-based strategies; and

WHEREAS, the safety of Elk Grove citizens is an important concern of the City Council.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to:

- 1) Accept the awarded grant funding up to up to \$100,000 from the California Office of Traffic Safety to implement an educational bicycle safety campaign for young riders, subject to final modifications and agreement between the City and OTS; and
- 2) Take all action and execute all documents and/or agreements reasonably necessary to receive the grant funding, all subject to approval of any documents and/or agreements by the City Attorney; and
- 3) Amend the Office of Strategic Planning and Innovation's revenue and expense budget equal to the amount received and expended each fiscal year until the total grant award has been received and expended.
