

ORDINANCE NO. 03-2017

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AMENDING ELK GROVE MUNICIPAL CODE CHAPTER 10.48 SPEED ZONES TO ESTABLISH THE SPEED LIMIT ON VARIOUS STREET SEGMENTS THROUGHOUT THE CITY

WHEREAS, with certain exceptions for prima facie speed limits for certain roadways, the California Vehicle Code (CVC) requires speed limits to be set by ordinance on the basis of an Engineering and Traffic Survey; and

WHEREAS, new Engineering and Traffic Surveys have been performed on various streets within the City; and

WHEREAS, new speed limits must be set and posted in conformance with these new Engineering and Traffic Surveys; and

WHEREAS, staff has identified additional amendments that reorganize Elk Grove Municipal Code Chapter 10.48 to make it easier to read and update in the future.

NOW, THEREFORE, the City Council of the City of Elk Grove does ordain as follows:

Section 1: Purpose and Authority

The purpose of this Ordinance is to amend the Elk Grove Municipal Code Chapter 10.48 Speed Zones to establish the speed limit on various street segments throughout the City, make the code more City-specific and group the streets in alphabetic order in accordance with their posted speed limits for ease of reference and future updates.

Section 2: Findings

On January 11, 2017, the City Council of the City of Elk Grove reviewed and considered the engineering and traffic surveys and related information, on file with the City's Department of Public Works and incorporated herein by reference.

Based on the review of the Surveys, the City Council finds that the most appropriate speed limit to facilitate the orderly movement of traffic that is reasonable and safe is as listed below;

1. Amber Creek Drive between Big Horn Boulevard (west) and Big Horn Boulevard (east) is 30 MPH
2. Bader Road between Bond Road and Calvine Road is 45 MPH
3. Big Horn between Franklin Boulevard and Portofino Drive is 45 MPH
4. Blossom Ridge Road between Franklin Boulevard and Whitelock Parkway is 35 MPH
5. Bruceville Road between Bilby Road and Karnmerer Road is 45 MPH
6. Bradshaw Road between Elk Grove Blvd and Grant Line Road is 45 MPH

7. Dwight Road between Laguna Boulevard and the Elk Grove City Limit is 35 MPH
8. East Lake between Drive Fassett Way and Peets Street is 35 MPH
9. E. Stockton Boulevard between Bond Road and Emerald Vista Drive is 40 MPH
10. E. Stockton Boulevard between Bond Road and Sheldon Road is 40 MPH
11. E. Stockton Boulevard between Grant Line Road and Elk Grove Boulevard is 40 MPH
12. E. Stockton Boulevard between Sheldon Road and Geneva Point Drive is 45 MPH
13. Foulks Ranch Drive between Elk Grove Boulevard and Laguna Park Drive is 30 MPH
14. Frye Creek Drive between Big Horn Boulevard (west) and Big Horn Boulevard (east) is 35 MPH
15. Gilliam Way between Bilby Road and McClean Drive is 30 MPH
16. Hampton Oak between E. Stockton Boulevard and Iron Rock Way is 40 MPH
17. Harbour Point Drive between Elk Grove Boulevard and Laguna Boulevard is 40 MPH
18. Kammerer Road between Bruceville Road and State Route 99 is 50 MPH
19. Kilconnell Drive between Bruceville Road and Foulks Ranch Drive is 30 MPH
20. Laguna Main Drive between Laguna Boulevard and Renwick Avenue is 25 MPH
21. Laguna Park Drive between Franklin Boulevard and Laguna Boulevard is 30 MPH
22. Laguna Springs Drive between Elk Grove Boulevard and Lotz Parkway is 35 MPH
23. Lent Ranch Parkway between Kammerer Road and Promenade Parkway is 40 MPH
24. Lewis Stein Road between Big Horn Boulevard and Sheldon Road is 35 MPH
25. Longleaf Drive between Big Horn Boulevard and Laguna Springs Drive is 35 MPH
26. Lotz Parkway between Big Horn Boulevard and Whitelock Parkway is 35 MPH
27. Maritime Drive between Lakepoint Drive and Harbour Point Drive is 35 MPH
28. Matina Drive between Willard Parkway and Gilliam Way is 35 MPH
29. Promenade Parkway between Kammerer Road and W. Stockton Boulevard is 45 MPH
30. Riparian Drive between West Taron Drive and East Taron Drive is 35 MPH
31. Seasons Drive between Bruceville Road and Laguna Park Drive is 30 MPH
32. Sheldon Road between Bruceville Road and State Route 99 is 40 MPH
33. Soaring Oaks Drive between Bruceville Road and Bruceville Road is 30 MPH
34. Springhurst Drive between Sheldon Road and West Camden Drive is 30 MPH
35. West Camden Drive between Elk Grove Florin Road and Springhurst Drive is 30 MPH
36. W. Stockton Boulevard between Auto Center Drive and a point 1300 feet south of Laguna Grove Drive is 35 MPH
37. W. Stockton Boulevard between Laguna Springs and a point 4150 feet south of Laguna Springs Drive is 40 MPH
38. West Taron Drive between Elk Grove Boulevard and Ruddy Duck Way is 35 MPH
39. Wymark Drive between Soaring Oaks and Elk Grove Boulevard is 30 MPH
40. Wymark Drive between Elk Grove Boulevard and Civic Center Drive is 35 MP

Section 3: Declaration of Speed Limits

The City Council hereby declares that speed limits be set in accordance with the findings and recommendations provided in the Table in Section 2 above.

Section 4: Direction to City Engineer

On or after the effective date of this ordinance, the City Engineer is directed to clearly post, or cause to be posted, speed limit signs effectuating Section 2, above, to give notice that this ordinance is in effect.

Section 5: Amendments to Chapter 10.48

Chapter 10.48 of the Elk Grove Municipal shall be replaced in its entirety to read as follows:

Chapter 10.48 SPEED ZONES

Sections

10.48.010 Speed zones

10.48.020 Speed limits

10.48.010 Speed zones.

The City Council has determined, on the basis of engineering and traffic surveys, that the speed permitted by the Vehicle Code upon certain roadways is not in conformance with the safe and efficient operation of vehicles thereon. The prima facie speed limits on such roadways or parts of such roadways shall be as specified by ordinance when signs are erected giving notice of such limits.

10.48.020 Speed limits.

City Council hereby declares that the following speed limits shall be enforced:

- A. A speed limit of 25 miles per hour shall apply to the following streets:
 - 1. Laguna Main Drive between Laguna Boulevard and Renwick Avenue;
 - 2. Lake Point Drive between Four Winds Drive and Babson Drive.

- B. A speed limit of 30 miles per hour shall apply to the following streets:
 - 1. Amber Creek Drive between Big Horn Boulevard (west) and Big Horn Boulevard (east);
 - 2. Auberry Drive between Geneva Pointe Drive and Power Inn Road;
 - 3. Backer Ranch Road between Bruceville Road and Elk Grove Boulevard;

4. Bellaterra Drive between the west intersection with Whitelock Parkway and the east intersection with Whitelock Parkway;
 5. Bilby Road between the City limits and Willard Parkway;
 6. Coop Drive between Franklin High Road and Bilby Road;
 7. Corfu Drive between Atlantis Drive and Excelsior Road;
 8. Cresleigh Parkway/Alesandria Drive between Elk Grove Boulevard and Bellaterra Drive;
 9. East Park Drive between Elk Grove Boulevard and West End Drive;
 10. Fire Poppy Drive between Elk Grove Boulevard and Bellaterra Drive;
 11. Foulks Ranch Drive between Elk Grove Boulevard and Laguna Park Drive;
 12. Four Winds Drive between Elk Grove Boulevard and Babson Drive;
 13. Franklin High Road between Whitelock Parkway West and Whitelock Parkway East;
 14. Gilliam Way between Bilby Road and McClean Drive;
 15. Kilconnell Drive between Bruceville Road and Foulks Ranch Drive;
 16. Laguna Park Drive between Franklin Boulevard and Laguna Boulevard,
 17. Laguna Park Drive between Laguna Boulevard East and Laguna Boulevard West;
 18. Machado Ranch Drive between Bruceville Road and Franklin High Road;
 19. Pleasant Grove School Road between Bader Road and Grant Line Road;
 20. Power Inn Road between Sheldon Road and Geneva Pointe Road;
 21. Seasons Drive between Bruceville Road and Laguna Park Drive;
 22. Soaring Oaks Drive between Bruceville Road and Bruceville Road;
 23. Springhurst Drive between Sheldon Road and West Camden Drive;
 24. Stonebrook Drive between East Park Drive and Bond Road;
 25. Terrazzo Drive between Bruceville Road and Bellaterra Drive;
 26. Trenholm Drive between Laguna Boulevard and Soaring Oaks Drive.
 27. West Camden Drive between Elk Grove Florin Road and Springhurst Drive;
 28. Wymark Drive between Soaring Oaks and Elk Grove Boulevard.
- C. A speed limit of 35 miles per hour shall apply to the following streets:
1. Blossom Ridge Road between Franklin Boulevard and Whitelock Parkway
 2. Civic Center Drive between Bruceville Road and Laguna Springs Drive;
 3. Dwight Road between Laguna Boulevard and the Elk Grove City Limit;
 4. East Lake between Drive Fassett Way and Peets Street;
 5. Elk Grove Boulevard between Laguna Springs Drive and State Route 99 South Bound;

6. Elk Grove Boulevard between State Route 99 South Bound and Elk Grove-Florin Road;
 7. Elk Grove Boulevard between Waterman Road and Bradshaw Road;
 8. Elk Grove-Florin Road between Elk Grove Boulevard and E. Stockton Boulevard;
 9. Elk Grove-Florin Road between Elk Grove Boulevard and Bond Road;
 10. Frye Creek Drive between Big Horn Boulevard (west) and Big Horn Boulevard (east);
 11. Grant Line Road between Bond Road and Sheldon Woods Way;
 12. Laguna Springs Drive between Elk Grove Boulevard and Lotz Parkway;
 13. Laguna Springs Drive between Laguna Boulevard and Elk Grove Boulevard;
 14. Lewis Stein Road between Big Horn Boulevard and Sheldon Road;
 15. Longleaf Drive between Big Horn Boulevard and Laguna Springs Drive;
 16. Lotz Parkway between Big Horn Boulevard and Whitelock Parkway;
 17. Maritime Drive between Lakepoint Drive and Harbour Point Drive;
 18. Matina Drive between Willard Parkway and Gilliam Way;
 19. Riparian Drive between West Taron Drive and East Taron Drive;
 20. W. Stockton Boulevard between Laguna Boulevard and Lewis Stein Road;
 21. Waterman Road between Rancho Drive and Mainline Drive/Dino Drive;
 22. West Lake Drive between Elberon Way and Nolan Street;
 23. W. Stockton Boulevard between Auto Center Drive and a point 1300 feet south of Laguna Grove Drive;
 24. West Taron Drive between Elk Grove Boulevard and Ruddy Duck Way;
 25. Whitelock Parkway between Franklin Boulevard and Bruceville Road;
 26. Whitelock Parkway between Bruceville Road and W Stockton Boulevard;
 27. Wymark Drive between Elk Grove Boulevard and Civic Center Drive.
- D. A speed limit of 40 miles per hour shall apply to the following streets:
1. Big Horn Boulevard between Franklin Boulevard and Bruceville Road;
 2. Big Horn Boulevard between Bruceville Road and Laguna Boulevard;
 3. Big Horn Boulevard between Laguna Boulevard and Elk Grove Boulevard;
 4. Big Horn Boulevard between Elk Grove Boulevard and Whitelock Parkway;
 5. Bruceville Road between Elk Grove Boulevard and Bilby Road;
 6. Bruceville Road between Elk Grove Boulevard and Sheldon Road;
 7. E. Stockton Boulevard between Bond Road and Emerald Vista Drive;
 8. E. Stockton Boulevard between Bond Road and Sheldon Road;
 9. E. Stockton Boulevard between Grant Line Road and Elk Grove Boulevard;

10. Elk Grove Boulevard between Bradshaw Road and Grant Line Road;
11. Hampton Oak Drive between E. Stockton Boulevard and Iron Rock Way;
12. Harbour Point Drive between Elk Grove Boulevard and Laguna Boulevard;
13. Lent Ranch Parkway between Kammerer Road and Promenade Parkway;
14. Sheldon Road between Bruceville Road and State Route 99;
15. Sheldon Road between State Route 99 and Elk Grove-Florin Road;
16. Sheldon Road between Elk Grove-Florin Road and Grant Line Road;
17. W. Stockton Boulevard between Laguna Springs and a point 4150 feet south of Laguna Springs Drive.

E. A speed limit of 45 miles per hour shall apply to the following streets:

1. Bader Road between Bond Road and Calvine Road
2. Big Horn between Franklin Boulevard and Portofino Drive;
3. Bruceville Road between Bilby Road and Kammerer Road;
4. Bradshaw Road between Elk Grove Blvd and Grant Line Road;
5. Bond Road between Waterman Road and Elk Grove-Florin Road;
6. Bond Road between Elk Grove-Florin Road to State Route 99;
7. Bond Road between Waterman Road and Bradshaw Road;
8. Bond Road between Bradshaw Road and Grant Line Road;
9. E. Stockton Boulevard between Sheldon Road and Geneva Point Drive;
10. Elk Grove Boulevard between Harbour Point Drive and Franklin Boulevard;
11. Elk Grove Boulevard between Franklin Boulevard Bruceville Road;
12. Elk Grove Boulevard between Bruceville Road and Laguna Springs Drive;
13. Elk Grove-Florin Road between Bond Road and Calvine Road;
14. Excelsior Road between Sheldon Road and Calvine Road;
15. Franklin Boulevard between Laguna Boulevard and Sac City Limit;
16. Franklin Boulevard between Laguna Boulevard and Elk Grove Boulevard;
17. Franklin Boulevard between Elk Grove Boulevard and Whitelock Parkway;
18. Grant Line Road between Bond Road and 650' South of Equestrian Drive;
19. Grant Line Road between Sheldon Woods Way and City Limits (North);
20. Laguna Boulevard between Harbour Point and Franklin Road;
21. Laguna Boulevard between Franklin Road and Bruceville Road;
22. Laguna Boulevard between Bruceville Road and State Route 99;
23. Promenade Parkway between Kammerer Road and W. Stockton Boulevard;
24. Waterman Road between Calvine Road and Sheldon Road;
25. Waterman Road between Sheldon Road and Bond Road;
26. Waterman Road between Bond Road and Rancho Drive;

27. Waterman Road between Dino Drive and Grant Line Road;
 28. Willard Parkway between Whitelock Parkway and Bilby Road.
- F. A speed limit of 50 miles per hour shall apply to the following streets:
1. Wilton Road between Grant Line Road and City Limits (South);
 2. Kammerer Road between Bruceville Road and State Route 99.

Section 6: No Mandatory Duty of Care.

This ordinance is not intended to and shall not be construed or given effect in a manner that imposes upon the City or any officer or employee thereof a mandatory duty of care towards persons and property within or without the City, so as to provide a basis of civil liability for damages, except as otherwise imposed by law.

Section 7: Severability.

If any provision of this ordinance or the application thereof to any person or circumstances is held invalid, such invalidity shall not affect other provisions or applications of the ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are severable. This City Council hereby declares that it would have adopted this ordinance irrespective of the invalidity of any particular portion thereof and intends that the invalid portions should be severed and the balance of the ordinance be enforced.


Section 8: Savings Clause

The provisions of this ordinance shall not affect or impair an act done or right vested or approved or any proceeding, suit or prosecution had or commenced in any cause before such repeal shall take effect; but every such act done, or right vested or accrued, or proceeding, suit or prosecution shall remain in full force and effect to all intents and purposes as if such ordinance or part thereof so repealed had remained in force. No offense committed and no liability, penalty or forfeiture, either civilly or criminally incurred prior to the time when any such ordinance or part thereof shall be repealed or altered by said Code shall be discharged or affected by such repeal or alteration; but prosecutions and suits for such offenses, liabilities, penalties or forfeitures shall be instituted and proceeded with in all respects as if such prior ordinance or part thereof had not been repealed or altered.

Section 9: Effective Date and Publication

This Ordinance shall take effect thirty (30) days after its adoption. In lieu of publication of the full text of the ordinance within fifteen (15) days after its passage, a summary of the ordinance may be published at least five (5) days prior to and fifteen (15) days after adoption by the City Council and a certified copy shall be posted in the office of the City Clerk, pursuant to GC 36933(c)(1).
