

RESOLUTION 2004-274

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE, TO UTILIZE THE STATE CITIZEN'S OPTION FOR PUBLIC SAFETY PROGRAM FUNDS

WHEREAS, under the State Supplemental Law Enforcement Services Fund (SLESF), the State appropriated funding for local law enforcement operations and services for Fiscal Year 2004-05; and

WHEREAS, Elk Grove's portion of the SLESF funding is anticipated to be approximately \$160,188; and

WHEREAS, under the condition of the program, the City of Elk Grove shall use SLESF funds exclusively to support front-line police operations and services; and

WHEREAS, the City Council, at a public hearing held on November 3, 2004, considered these written requests separate and apart from the process applicable to propose allocations of the City General Fund.


NOW, THEREFORE, BE IT RESOLVED AND ORDERED that the City Council of the City of Elk Grove hereby accepts the grant for the State Citizen's Option for Public Safety funding and increases the Fiscal Year 2004-05 Fund 218 (State COPS Grant) revenue and expense budget from \$117,500 to \$161,000.


