**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
APPROVING A PUBLIC CONVENIENCE AND NECESSITY LETTER  
SACRAMENTO NATURAL FOODS CO-OP, PROJECT #EG-04-668**

**WHEREAS**, Sacramento Natural Foods Co-op (hereinafter referred to as Applicant) filed an application with the City of Elk Grove (hereinafter referred to as City) for a Public Convenience and Necessity Letter to obtain a Type 20 Off-sale (beer and wine) alcohol license (Assessor's Parcel Numbers 116-0041-015); and

**WHEREAS**, Title 4, Chapter 4.60, of the City of Elk Grove Municipal Code establishes the City Council as the appropriate authority to hear and decide all Public Convenience and Necessity Letters; and

**WHEREAS**, the project is exempt under the California Environmental Quality Act (CEQA) Section 15061 (3); and

**WHEREAS**, a duly advertised public hearing notice; in accordance with Government Code Section 65090 et al. and a public hearing was conducted by the City Council on November 17, 2004; and

**WHEREAS**, after careful consideration of all the written materials and testimony received, the City Council approved the project.


**NOW, THEREFORE, BE IT RESOLVED**, the City Council of the City OF Elk Grove hereby resolves as follows:

Approve the request for a Type 20 Off-sale (beer and wine) alcohol license.


