- A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY ENGINEER TO APPROVE CHANGE ORDERS NOT-TO-EXCEED \$25,790.45 FOR THE 2014 CITYWIDE CURB RAMP IMPROVEMENTS PROJECT (CAPITAL IMPROVEMENT PROJECT ID WAC007); ACCEPTING THE 2014 CITYWIDE CURB RAMP IMPROVEMENTS PROJECT AS COMPLETE; AND AUTHORIZING THE CITY ENGINEER TO PREPARE AND THE CITY CLERK TO FILE THE NOTICE OF COMPLETION WITH THE SACRAMENTO COUNTY RECORDER
- WHEREAS, on April 23, 2014 the City Council authorized the award of a construction contract to Sierra National Construction dba Sierra National Asphalt for the 2014 Citywide Curb Ramp Improvements Project (Capital Improvement Project ID WAC007) (the "Project"); and
- WHEREAS, the Project reconstructed thirty (30) curb ramps, including curb, gutter and sidewalk, to meet current Americans with Disabilities Act (ADA) slope and access requirements; and
- WHEREAS, the amount of aggregate base material quantity needed for the Project exceeded the original estimate; and
- WHEREAS, the final construction amount plus change orders exceeded the original total authorized amount of \$165,432.00 by \$4,212.45; and
- WHEREAS, Sierra National Construction dba Sierra National Asphalt has completed the work in accordance with the terms and conditions of the contract documents for the Project; and
- WHEREAS, if no liens or claims have been filed within thirty-five (35) days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to Sierra National Construction dba Sierra National Asphalt
- NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Engineer to approve change orders not-to-exceed \$25,790.40.
- **BE IT FURTHER RESOLVED** that the City Council of the City of Elk Grove hereby accepts the 2014 Citywide Curb Ramp Improvements Project as complete.
- **BE IT FURTHER RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.
