A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE THE SECOND AMENDMENT
TO AND RESTATEMENT OF THE FRANCHISE AGREEMENT BETWEEN THE CITY
OF ELK GROVE AND ALLIED WASTE SERVICES OF NORTH AMERICA, LLC;
SUBSIDIARY OF REPUBLIC SERVICES, INC. FOR RESIDENTIAL REFUSE AND
SHARPS COLLECTION AND TRANSPORTATION TO DISPOSAL FACILITIES AND
RECYCLABLES, GREEN WASTE, AND E-WASTE COLLECTION,
TRANSPORTATION, PROCESSING AND MARKETING

- WHEREAS, the City of Elk Grove entered into an amended and restated Franchise Agreement with Allied Waste Services of North America, LLC ("Allied Waste"); subsidiary of Republic Services, Inc. on October 14, 2009; and
- WHEREAS, the Franchise Agreement was amended on July 24, 2013 to enhance services for the City of Elk Grove by providing service to public trash and recycling containers located at bus stops citywide and at various locations in Old Town Elk Grove; and
- WHEREAS, a number of additional collection services are now offered by Republic Services such as used motor oil and oil filter collection, sharps collection, etc., which have resulted in additional recyclable materials being collected; and
- WHEREAS, the definition of diverted material in the agreement should to be updated to include the additional recyclable materials collected but not previously counted as diverted; and
- WHEREAS, the calculation of the Minimum Diversion Requirement should be clarified to specifically identify the measurement of total materials collected and total materials diverted; and
- WHEREAS, the calculation of the Minimum Diversion Requirement should be updated to include the additional recyclable material collected through new programs; and
- **WHEREAS**, the Franchise Agreement contains a number of typographical errors that should be corrected as part of this Restatement of the Agreement.
- **NOW, THEREFORE, BE IT RESOLVED** that the City Manager is hereby authorized to execute the Second Amendment to and Restatement of the Franchise Agreement between the City of Elk Grove and Republic Services, Inc.
