## **RESOLUTION NO. 2015-037**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO DISPENSE WITH THE COMPETITIVE BIDDING PROCESS PER MUNICIPAL CODE SECTION 3.42.180(B)(3) AND EXECUTE AN AGREEMENT WITH LENCO INDUSTRIES FOR THE PURCHASE OF A REPLACEMENT INCIDENT RESPONSE VEHICLE IN AN AMOUNT NOT-TO-EXCEED \$274,574

WHEREAS, in March 2014 the Elk Grove Police Department submitted a grant application to the County of Sacramento State Homeland Security Grant Program (SHSGP) for the purchase of a replacement Emergency Incident Response Vehicle to support the south county of Sacramento in the event of a natural or man-made threat or disaster; and

**WHEREAS**, the vehicle to be replaced is over 20 years old and has 264,000 odometer miles; and

WHEREAS, the Lenco BearCat Incident Response Vehicle will become an extension of the Elk Grove Emergency Operations Center and Police Department, offering a unified command center that can be deployed expeditiously and improve catastrophic incident planning, response and recovery; and

WHEREAS, other local jurisdictions are already using and training with a Lenco Bearcat and interoperability is crucial during a multi-jurisdictional incident response; and

WHEREAS, interoperability was a criteria for receipt of grant funding; and

**WHEREAS**, pursuant to Elk Grove Municipal Code Section 3.42.180(B)(3), the City Council may dispense with the competitive bidding process when it is not in the best interest of the City to do so; and

WHEREAS, pricing for the BearCat has been negotiated by the City's Fleet Manager while comparing negotiated pricing currently listed in the Federal General Services Administration Agreement (GSA# GS-07F-0390M); and

WHEREAS, for the reasons presented, the City Council finds that pursuing competitive bidding for this item is not in the best interest of the City and it is proper to dispense with such bidding here;

WHEREAS, there is sufficient grant funding to make this full purchase.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby dispenses with the competitive bidding process per Elk Grove Municipal Code Section 3.42.180(B)(3) and authorizes the City Manager to execute an agreement with Lenco Industries for the purchase of a replacement Incident Response Vehicle in an amount not-to-exceed \$274,574.
