

RESOLUTION NO. 2015-038

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE ACCEPTING THE ELK GROVE-FLORIN ROAD AND EAST STOCKTON BOULEVARD INTERSECTION REALIGNMENT PROJECT (CAPITAL IMPROVEMENT PROJECT ID PT0085) AS COMPLETE, AND AUTHORIZING THE CITY ENGINEER TO PREPARE AND THE CITY CLERK TO FILE THE NOTICE OF COMPLETION WITH THE SACRAMENTO COUNTY RECORDER

WHEREAS, on November 13, 2013 the City Council authorized the award of a construction contract to Sierra National Construction, Inc. for the Elk Grove-Florin Road and East Stockton Boulevard Intersection Realignment Project (Capital Improvement Project ID PT0085) (the "Project"); and

WHEREAS, the Project realigned and signalized the intersection at Elk Grove-Florin Road and East Stockton Boulevard, including turn lanes, bike lanes, medians, minor drainage improvements and modifications to a portion of the Elk Grove Regional Park's parking lot, including landscaping and irrigation; and


WHEREAS, Sierra National Construction, Inc. has completed the work in accordance with the terms and conditions of the contract documents and authorized change orders for the Project; and

WHEREAS, if no liens or claims have been filed within thirty-five (35) days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to Sierra National Construction, Inc.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby accepts the Elk Grove-Florin Road and East Stockton Boulevard Intersection Realignment Project as complete.

BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.
