A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE PUBLIC WORKS DIRECTOR / CITY ENGINEER TO APPLY FOR AND TO EXECUTE THE NECESSARY DOCUMENTS FOR A COOPERATIVE WORK AGREEMENT EXTENSION BETWEEN THE CITY OF ELK GROVE AND STATE OF CALIFORNIA, DEPARTMENT OF TRANSPORTATION (CALTRANS), WHICH WILL EXTEND THE PERIOD OF TIME TO EXPEND THE FEDERAL SAFE ROUTES TO SCHOOL (SRTS) GRANT FUNDS FOR THE PROJECT AWARE (ADVANCING WALK AND ROLL ENVIRONMENTS) BEING IMPLEMENTED BY THE ELK GROVE UNIFIED SCHOOL DISTRICT (EGUSD), CITY PROJECT EGUSD1, STATE PROJECT SRTSLNI-5479(038) (CEQA EXEMPT)

WHEREAS, the City of Elk Grove has undertaken the Federal Safe Routes to School Grant in partnership with Elk Grove Unified School District (EGUSD) for the Project AWARE (Advancing Walk and Roll Environments) within the boundaries of the Elk Grove School District; and

WHEREAS, the EGUSD applied for and received a grant from the State of California, Dept. of Transportation in 2012 for the Federal Safe Routes to School, Project AWARE non-infrastructure funding toward implementation of the SRTS grant; and

WHEREAS, the City agreed to manage the grant expenditures in accordance with State and Federal requirements on behalf of EGUSD and pass-through any grant reimbursements to EGUSD; and

WHEREAS, the SRTS funding will lapse on June 30, 2017; and

WHEREAS, the City of Elk Grove can apply for a Cooperative Work Agreement Extension to extend the State funding authorization for the project; and

WHEREAS, the proposed action will not result in any physical change to the environment and is, therefore, not a "project," as defined under the California Environmental Quality Act (CEQA); and

WHEREAS, the City Council of the City of Elk Grove or its authorized representative must apply for and sign documents for the Cooperative Work Agreement Extension.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the Public Works Director / City Engineer to apply for and execute the necessary documents for a Cooperative Work Agreement Extension between the City of Elk Grove and Caltrans for this project.
