## RESOLUTION NO. 2017-075

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE RESCINDING RESOLUTION NO. 2017-016 AND AUTHORIZING THE CITY MANAGER TO APPLY FOR GRANT FUNDING FROM THE U.S. DEPARTMENT OF JUSTICE DRUG INFORCEMENT ADMINISTRATION TO IMPLEMENT A STRATEGIC ENFORCEMENT INITIATIVE AS PART OF THE ORGANIZED CRIME DRUG ENFORCEMENT TASK FORCE AND AMEND THE POLICE DEPARTMENT'S BUDGET UP TO \$50,000 IF AWARDED

WHEREAS, the U.S. Drug Enforcement Administration (DEA) oversees the Organized Crime Drug Enforcement Task Forces (OCDETF), a program whose mission is to identify, disrupt, and dismantle drug trafficking and money laundering organizations through cooperative measures; and

**WHEREAS**, OCDETF has requested the cooperation of the Elk Grove Police Department in a strategic enforcement initiative that will require officers to work periodic overtime; and

**WHEREAS**, the Elk Grove Police Department continues to be an active partner with the DEA and other law enforcement agencies in the eradication of illegal drugs; and

WHEREAS, the DEA initially awarded the Elk Grove Police Department \$15,000 for overtime hours worked by officers participating in this program and has now committed to \$35,000; and

**WHEREAS**, additional DEA grant funding may become available to the Elk Grove Police Department during this project period.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby rescinds Resolution 2017-016 and authorizes the City Manager to apply for and receive grant funding from the U.S. Department of Justice Drug Enforcement Administration to implement a strategic enforcement initiative as part of the Organized Crime Drug Enforcement Task Force and amend the Police Department's budget each fiscal year until the full grant award is expended up to \$50,000.
