A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH FORMAL REQUEST FOR PROPOSAL (RFP) PROCEDURES PURSUANT TO ELK GROVE MUNICIPAL CODE SECTION 3.42.188(B)(3); AND AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH DELTA WIRELESS, INC. FOR THE PURCHASE AND INSTALLATION OF A DIGITAL RADIO SYSTEM FOR THE CITY'S TRANSIT FLEET IN AN AMOUNT NOT TO EXCEED \$228,606

WHEREAS, in January 2015, City staff applied for \$228,606 of Proposition 1B Transit Safety and Security grant funds through the California Office of Emergency Services (Cal OES) which the Sacramento Area Council of Governments (SACOG) awarded \$222,084 and \$6,522 was directly allocated to the City through the grant program; and

WHEREAS, the project will allow the City to update its transit fleet's antiquated analog radio system, which is approximately ten years old, with an updated digital radio system; and

WHEREAS, the Sacramento Regional Radio Communications System (SRRCS) is a network of radio communications equipment that supports a regional public safety/public service partnership of which the City is a member; and

WHEREAS, in May, 2016 the County of Sacrarnento, with input from members of SRRCS, entered into a master purchase agreement with Motorola for digital radios and services which gives agencies utilizing the SRRCS the ability to purchase radios and services utilizing this agreement; and

WHEREAS, by combining the buying power of all the agencies associated with the SRRCS, the County was able to negotiate discounts on radios and services, exceeding which each individual agency would be able to negotiate on their own; and

WHEREAS, it is in the City's best interest that the contract be made pursuant to Elk Grove Municipal Code Section 3.42.188(B) (3), which allows dispensing with the formal RFP procedures when, in the judgment of the City Council, compliance with the procedure is not in the best interest of the City; and

WHEREAS, Motorola Solutions, Inc. has designated Delta Wireless, Inc. as the Manufacturer Representative (MR) for this purchase as Delta Wireless, Inc. is a sales agent for Motorola.

NOW, THEREFORE, BE IT RESOLVED that, for the reasons presented, the City Council of the City of Elk Grove adopts a resolution finding that it is in the City's best interests to dispense with formal RFP procedures pursuant to Elk Grove Municipal Code Section 3.42.188(B)(3); and

BE IT FURTHER RESOLVED, that the City Council of the City of Elk Grove authorizes the City Manager to execute a contract with Delta Wireless, Inc. for the purchase and installation of a digital radio system for the City's transit fleet in an amount not to exceed \$228,606 in substantially the form presented.
